RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT (CALIFORNIA SPORTS FACILITY)

2. DEFINITIONS

"Activities" means all soccer-related programming including training, games, leagues, camps, clinics, tournaments, events, and recreational play.

"Facility Premises" means all areas owned, leased, operated, controlled, or used by Formula Soccer, including but not limited to playing fields, turf areas, spectator zones, seating areas, walkways, entrances, exits, parking areas, restrooms, and any surrounding or adjacent areas used in connection with Activities.

"Released Parties" means Golazo Soccer Center LLC dba Formula Soccer and its owners, officers, employees, agents, contractors, volunteers, affiliates, insurers, and representatives.

3. EXPRESS ASSUMPTION OF RISK (CALIFORNIA CIVIL CODE §1542 WAIVER INTENT)

I acknowledge that participation in Activities and presence on Facility Premises involves inherent risks including serious bodily injury, permanent disability, paralysis, death, property damage, and other losses.

These risks include but are not limited to:

- Collisions with players, spectators, or objects
- Slips, trips, and falls on turf or hard surfaces

- Equipment failure or facility conditions
- Contact injuries including concussions and fractures
- Risks caused by other participants, spectators, or third parties
- Medical emergencies and delayed treatment

I voluntarily assume all risks, whether known or unknown, including those arising from the ordinary negligence of the Released Parties to the fullest extent permitted by California law.

I expressly waive the protections of California Civil Code §1542, which states that unknown claims are not released, and I knowingly waive any such rights.

4. RELEASE AND WAIVER OF LIABILITY (INCLUDING NEGLIGENCE)

I, on behalf of myself and my heirs, assigns, and representatives, hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the Released Parties from any and all claims arising out of participation in Activities or presence on Facility Premises, INCLUDING CLAIMS ARISING FROM THE ORDINARY NEGLIGENCE OF THE RELEASED PARTIES, to the fullest extent permitted by California law.

5. INDEMNIFICATION, DEFENSE, AND HOLD HARMLESS

I agree to INDEMNIFY, DEFEND, AND HOLD HARMLESS the Released Parties from any claims, liabilities, damages, losses, and expenses (including attorneys' fees) arising out of:

- (a) my acts or omissions;
- (b) violation of Facility rules;
- (c) damage to property;
- (d) any claim brought by any third party arising from my conduct or presence on Facility Premises.

This obligation survives termination of this Agreement.

6. MINORS AND PARENTAL AUTHORIZATION

If Participant is under 18, the parent/guardian:

- Acknowledges authority to sign on behalf of the minor
 - Agrees to bind both themselves and the minor to this Agreement
 - Understands they are waiving legal rights on behalf of the minor to the fullest extent permitted by law

7. SIBLINGS, GUESTS, SPECTATORS, AND CONTROL OF PREMISES

The undersigned acknowledges that siblings, family members, guests, spectators, and other minors may enter Facility Premises in connection with Activities.

The undersigned agrees that:

- All such individuals are under the control, supervision, and responsibility of the undersigned
- Their presence is voluntary and at their sole risk
- They are subject to all Facility rules and inherent risks described in this Agreement

The undersigned further agrees that **entry onto Facility Premises constitutes acknowledgment and acceptance of the risk terms of this Agreement**, regardless of whether such individuals have separately signed a waiver.

8. NON-SIGNER BAR / IMPLIED ASSUMPTION OF RISK (NEXT-LEVEL PROTECTION CLAUSE)

To the fullest extent permitted by California law, any person who enters, observes, assists, or remains on Facility Premises in connection with Activities, including spectators, siblings, guests, or accompanying minors:

- is deemed to have voluntarily assumed all risks associated with Facility Premises, and
- is bound by the risk allocation, waiver, and release provisions of this Agreement as a condition of entry, participation, or presence, whether or not they have signed a separate waiver.

If any such individual is a minor, the undersigned parent or guardian agrees that their presence is authorized under this Agreement and subject to its terms.

9. CONDITION OF ENTRY / FAILURE TO SIGN

The Facility's permission for any individual to enter Facility Premises is expressly conditioned on acceptance of the risk allocation in this Agreement.

If any individual refuses to sign a required waiver when requested by Facility staff, the Facility may deny entry or remove such individual without refund.

Failure of any individual to sign a separate waiver does not create or imply any duty of care beyond that assumed under this Agreement, to the fullest extent permitted by law.

10. MEDICAL AUTHORIZATION AND COST RESPONSIBILITY

I authorize emergency medical treatment and agree I am responsible for all associated costs.

11. RULES AND REMOVAL

The Facility may remove any person from Activities or Facility Premises for safety or conduct reasons without refund.

12. MEDIA RELEASE

I grant permission for use of my likeness for promotional purposes without compensation.

13. SEVERABILITY; GOVERNING LAW; INTENT OF ENFORCEABILITY

This Agreement is governed by California law. If any provision is held invalid, the remainder remains enforceable.

The parties intend this Agreement to be interpreted as broadly and enforceably as permitted under California law governing recreational risk assumption and liability waivers.

14. VOLUNTARY SIGNATURE

I acknowledge I have read and understood this Agreement, understand I am waiving important legal rights including the right to sue, and sign voluntarily.
